Terminology is a subsystem of the general lexical system of the language, which is reflected as a system of scientific terms. A constant close connection exists between terminology and common literary language. A term is encountered when it enters a non-specialized language domain to a connotation that leads to a full (determinologization) generalizing word.

Determinologization (de-terminization, loss of connection of a term with a scientific concept and turning it into a generalizing word) means cases of taking words and phrases from a certain terminological system and fully acquiring them in the language of fiction. In the field of linguistics, the phenomenon of determinologization arises for two reasons. One of them is explained by the external, i.e., extralinguistic process: the development of science and technology, the growth of their role in the life of society, and the wide dissemination of scientific knowledge. The second is linguistic, i.e., internal linguistics, which arose as a result of systematic connections and relations within the language. Today, in the methodology of foreign language teaching, the emphasis on teaching the language for special purposes has increased. In this case, it is important to study the terms related to the special field. This certainly corresponds to the first cause of the phenomenon of determinologisation in the field of linguistics. The development of science and technology is the reason for the emergence of various terms and their presentation in the field of linguistics with specific lexical units.

#### **Conclusion**

The process of determinologizing is based on the level of involvement of the general public in the field of activity of a small professional group.

At the same time, in the field of electronics and cybernetics, there are differences between concepts in terminological systems that depend on the centuries-old history of the language developed depending on the long history, specific natural climate and other conditions, and the determinization of the term that appeared in the memory of one or two generations. The wide distribution of terminological vocabulary related to such areas and common vocabularies make it difficult to define certain boundaries.
