While the share of small business and private entrepreneurship in the Gross Domestic Product of the Republic of Uzbekistan was 31% in the 2000s, by 2021 this figure reached almost 55%. The share in industrial production, in turn, rose from 13% (2000-th year) to 27% (2021-th year). The share of small business and private entrepreneurship in the construction sector has grown significantly over the years, which is especially noticeable in recent years. A special place in the country's exports and imports is also occupied by small businesses and private businesses. It is worth noting that over the given years, the share of private entrepreneurs in exports increased from 10% to 22%, while during this time it can be observed that the import rate increased from 23% to 49%.

Private entrepreneurship differs slightly from small business in that the formation of financial resources and economic resources (the entrepreneur's own property, inheritance, borrowed or leased property, etc.) is based on strictly private property, and personal initiative occupies a high place. More than fifty decrees and resolutions of the president of the Republic of Uzbekistan have been adopted in the last three years in order to support representatives of this sphere from all sides.
